MINUTES OF REGULAR MEETING, FEBRUARY 11, 2025

- 1. CALL TO ORDER: Chair Pennisi called the meeting to order at 7:00 PM. Committee members Pennisi, Wais, Ritchey and Cantu-Reyna were present. District Secretary (DS) Rivas was present.
- 2. CALL FOR REQUESTS TO CONSIDER ITEMS OUT OF ORDER: None.
- 3. PUBLIC COMMENTS ON NON-AGENDA ITEMS: A resident inquired about what can be done about sideshows, citing that one had occurred on the day of the meeting. Deputy Castillo confirmed that CHP is responsible for dealing with sideshows. The Crockett Improvement Association will also investigate what can be done to deter sideshows. A concern was raised regarding 18-wheeler trucks causing property damage. A call was placed on the issue, which Deputy Castillo confirmed was routed to CHP and there are no additional updates.

4. LAW ENFORCEMENT ISSUES AND REPORTS

- a. REPORT FROM DEPUTY: Deputy Castillo reported 235 calls to service, resulting in 23 reports generated. The reports included towed vehicles, drug possession, court-ordered violation, battery, vehicle fleeing from deputy on Cummings Skyway, vandalism, burglary of an abandoned house, and burglary of a bicycle. There is a lead on who the bicycle thief is but cannot confirm if it was this person. For the crime trend, 4 crimes as compared to 6 in December for select crimes. A resident asked if a report would be filed if a "prowler" is reported on a private property. This would depend on the circumstances. Committee member Cantu-Reyna requested for Deputy Castillo to get crime trend data to show the impact of cameras in San Pablo.
- b. <u>REPORT FROM CHP ON TRAFFIC ISSUES</u>: CHP was not in attendance.
- c. NEIGHBORHOOD WATCH: None.

5. <u>ADMINISTRATIVE:</u>

- a. <u>UPDATE ON LPRS (LICENSE PLATE READERS)</u>: Committee member Wais confirmed that the Board has reviewed the grant application and has approved to move forward with the submission. The grant application will be due at the end of March. No updates on funds from Rodeo Renewal, the Committee can follow up on the status of funds by reaching out to the County Supervisor.
